22,000+ children and their families benefitted from child care information and referrals through **567,411** phone calls and online searches



CCR supported **1,166 homeless children** from **698 families** with child care subsidy and/or service coordination



6,123 children and their **4,496 caregivers**, participated in KP&L groups statewide with **51%+** speaking a language other than English at home



62 aspiring early learning teachers graduated prepared to care for children, representing **21 nationalities** and **24 languages**.



CCR coached **1,550+ licensed child care programs** (who collectively care for **33,130+ children**), 88% of which rated an Early Achievers Level 3 or higher, which indicates a quality level of excellence



FAMILY RESOURCE CENTER

Parents of nearly 2/3 of America's children are in the workforce and in need of child care. CCR provides information and resources to families in search of care for their young children.

HOMELESS CHILD CARE PROGRAM

In 2017, 782 families experienced homelessness in King County, not including families living in motels, or with friends. Having children in safe, nurturing care helps curb the trauma homeless children are subject to, and allows parents to take necessary steps to lift their family out of homelessness.

KALEIDOSCOPE PLAY & LEARN

A majority of families rely on family members or friends to care for their young children. CCR provides child development curriculum and structure for facilitated community groups to support those families preparing their children for kindergarten.

CHILD CARE CAREERS PROGRAM

Across our region, there is a lack of available child care slots, and a lack of diversity among child care professionals. CCR trains and certifies aspiring early learning professionals to begin work in child care programs, or start their own child care business. We are also increasing diversity within this field so that children can see their own cultures reflected in their early learning environments.

QUALITY IMPROVEMENT

Children who benefit from high quality early learning experiences are more likely to graduate from high school and attend college than those who do not, and less likely to be incarcerated or suffer from chronic health problems later in life. Our coaches work with child care providers across King and Pierce Counties to help them improve the quality of their care.
